Price's Café is a museum-style exhibition that honours the unusual role that a Moruya café played in 1950s and 60s Australia in the reconciliation process. Using video interviews, photographs, music and a recreated café setting, the exhibition brings to life an almost-forgotten moment in the social history of the region.

Toni Houston worked as a cinematographer, interviewer and editor for the Prices Café project in 2013. Toni filmed interviews with Aboriginal Elders in Moruya, Narooma and Eden. She edited these interviews into a series of short pieces that focused on the themes of the exhibition. From a technical point of view, Toni delivered high quality videos that were well framed, had clear audio and edited with skill and care.

On a personal level Toni showed great sensitivity and care for the interview subjects. She made the Elders fell at ease and comfortable in talking about their lives, which in many cases dealt with highly personal and emotional experiences. As an interviewer, Toni asked insightful questions that explored the lives of the subjects.

Additionally, Toni filmed and edited a short video using interviews with the Price sisters, filmed in the space where the café was located. This video captured the characters of the sisters and the entertaining stories they told of their lives working with their parents in the café.

I would highly recommend Toni's work in the social documentary genre, with her particular focus on privately commissioned films and a particular passion for documenting indigenous stories in our local area.



I first met Toni in March of 2000 when she was employed aboard the M.S. Caledonian star as an Assistant Expedition Leader. In June of 2001 I hired her to be the onboard Video Chronicler for the Caledonian Star. The duties she had to perform demanded a very comprehensive depth of skills in all phases of the video production process including camera, sound, editing, scripting, narration and duplication.

Toni is a very skilled documentary maker who brought to the job of Chronicler a very profound understanding of what an expedition encompasses. Her knowledge of expedition travel along with her consummate skills in the area of documentary making and her total dedication to creating the best possible program in the face of physical and mental hardships added a uniqueness to the onboard Video Chronicle program that has been unmatched to date.

To create a Video Chronicle of an expedition that both documents and entertains is a hard task to accomplish. The skillset required includes the operation of the Sony PD150 camera and its associated audio equipment, the Shure FP33 mixer, Samson wireless lavaliere and Sennheiser ME66 microphones.

The most important ability, and with Toni her most valuable skill, for a Video Chronicler to have is the operation of the Canopus DV Storm Non Linear Edit system. This Windows based computer edit system is integral to delivering a quality program in such a short timeframe. The speed, reliability and tool set of this system is unmatched by any other Edit system on the market today and demands an accomplished editor to make the magic that I demand from the Video Chroniclers who work for me.

As a "one person production team" the Video Chronicler must wear many hats including Producer, Director and Technician. They must have the technical expertise to maintain the computer system and to handle the duplication of VHS tapes and the MPEG compression and mastering to DVD of the program ready to replicate aboard the ship in time for our guests to take home the video chronicle when they disembark.

The pressures to create a finished program both on time and with the highest level of creative skill is something that very few people can achieve. Add to that the pressures of performing the job on a floating platform that crosses some of the roughest seas on earth from the Antarctic to the Arctic, working 14 hours a day 7 days a week for 5 straight weeks and you have a very unique individual.

Toni Davis is just that, a unique individual who's skills at story telling are matched by her technical prowess. I can recommend Toni for any role in a production team whether it be as Director, Producer, Scriptwriter, Cameraman, or Editor.
